

13TH AND 14TH

I, the undersigned _____ give over to HaRav Yisroel Aryeh ben HaRav Simcha Shmuel zt"l SHULMAN Shlitah, on the 13th and 14th of Nison 5786, all rights pertaining to all types of chometz and/or mixtures with chometz that are mine, or belong to others, that I am permitted to sell, as well as the places that said chometz may be.

1. The above is specifically to be taken to mean that he may sell any material that is mine that may be chometz or suspected chometz, either purely so e.g. bread, grains, beer, whiskey, or as a mixture, e.g. coffee, preservatives, medicines, _____ and any other material that might have suspected chometz, e.g. grains, pickles, and/or any other type of chometz, or dried out and/or caked chometz that is stuck to utensils and/or any boxes, bags or wrappings that do not require 'tevila' when bought from a Goy, if there is chometz adhering to them, which are to be found in Kiryat Yearim Telz Stone _____

_____ as well as any other place that there might be found.

2. Also to be leased up to two weeks from the 13th day of Nison _____

3. In addition to be leased up to two weeks from the 14th day of Nison _____ as well as any other places that I am permitted to lease, that may have the above mentioned type of chometz etc. there

4. For all of the above I appoint HaRav Yisroel Aryeh ben HaRav Simcha Shmuel zt"l SHULMAN Shlita to sell before the time of 'Issur Chometz', the chometz, mixture of chometz, and suspected chometz previously detailed as well as to lease the above mentioned places as well as any other place that may have the above mentioned type of chometz etc. there. This appointment to sell and to lease may be exercised by himself personally or by his appointed representative, and to whomever wishes at whatever price that might be fixed, at whatever conditions he may choose including for credit, and using any type of 'kinyan' that he chooses. I hereby declare that his hand is as mine, his word is as mine, and his declaration is as mine.

5. From moneys received from the Goy towards buying and renting the above, he is allowed to take up to ten shekels.

6. It is his right to allow the buyer free access through my property to the above mentioned chometz etc. including through property which is rented or borrowed by me.

7. I obligate myself to give over the keys to the buyer upon his demand.

8. In addition, he has the right to declare this chometz ownerless property and/or to nullify it.

9. It is agreed that even if part of the above details are not valid, those remaining will take effect.

10. Any condition made upon me in the bill of sales I am bound to observe without argument or demur.

11. I waive any rights to nullification in any way.

12. For the purpose of the State, this bill of sale shall be considered absolute and this document shall be considered an irrevocable power of attorney.
